1. Name of the work : Construction of Floor Foundations up to G.C.I. Sheet Walling with Litch Pit of Wet Waste Processing unit [10.5M x 10M] at Khal bandh (HUP ground) within Tarakeswar Municipality, in Ward No -11, P. S. - Tarakeswar, Dist.- Hooghly.
2. Name and Address of the Executive Authority : Chairperson, Tarakeswar Municipality, Dt.-Hooghly.
3. Estimated amount : ₹ 484556.44
4. Earnest Money : ₹ 29691.00  
Earnest Money to be paid in-favour of the Chairman, Tarakeswar Municipality in the form of Bank Draft/Pay order Drawn on any nationalized Bank within West Bengal and must accompany with the NIT without which the TENDER will be summarily rejected.

Eligibility to Purchase and submit Tender : The intending Tenderers, PWD enlisted (1<sup>st</sup> class) or bonafide outside or working contractors under the Govt. who have successfully completed similar nature of works having experience in construction works in a single contract within last 3(three) yrs. from the date of this Tender and also having up to date clearance certifications of P.T. Pan card & GST. The Tender who were allowed to purchase Tender papers for last 3(three) Tender of this circle but did not participate in any two of the such Tender, they are not eligible to participate in this Tender and working contractors whose performances are not satisfactory will not be allowed to participate in this Tender.
6. Printed Form in which Tender is to be submitted. : West Bengal Form No.2911 (ii) including up to date corrigenda and agenda as per order of Government.
7. Price for per set of Tender documents : Tender documents can be obtained on cash payment of non- refundable fee of Rs.1000/- (One thousand only) from the office of the Tarakeswar Municipality.
8. Last date & time for receipt of application seeking permission of purchase Tender documents. : 28.12.2021 up-to 2 P.M. (I.S.T.) applications in duplicate accompanied by photocopies (duly attested) of all credentials e.g. Work order, Payment certificate, Completion certificate for the respective work along with valid certificates in original mentioned in Chairperson, Tarakeswar Municipality, Dist.- Hooghly in absence of any of these documents the application will not be considered for permission.

13. Time of completion of Work : 30 days from the date of issued work order.

Deduction of CESS@1% : CESS @1% of the cost of construction work would be deducted from the bills Additionally apart from other statutory deduction like GST/IT etc. as per notify - action no.1182 - IR dt.20.09.05 of Labour Department. Rate quoted by the tenders shall be deemed to have made the provision on his/her own accordingly.

If the office of the Tarakeswar Municipality happens to be closed on the date of receiving and opening of Tender documents these will be received and opened on the next working day at the same time & venue without any further notice.

Tender documents in sealed cover containing the entire Tender must be super scribed with the name of the work and Tender notice No. Tender will be opened in presence of the participants or authorized representatives who intend to be present at the time of opening.

Tender submitted in any form other than the Tender documents issued in-favour of Tender is liable to be rejected. Tender documents with missing pages or schedule items will be disqualified and it will be the Tender responsibility to point out any short coming in documents furnished well before the date of submission for needful action, if any by the office.

Tender documents and other relevant particulars may be seen by the intending Tender during office hours in the office of the Tarakeswar Municipality. Application (in duplicate) along with credentials etc. shall have to be submitted to the concerned Department of this office, Prior to the purchase of the Tender papers.
